## Detention & Bail

**Bail is ALWAYS an option for people in detention.**

MUN NGA KO DEHFALSA BOPA

### Two types of bail application:

1. Apply to the Home Office (Form 401)
2. Apply to First Tier Tribunal (B1 form) - independent immigration judges

### TOP TIPS:

Keep a copy of ALL documents that you send or receive from the Home Office or your lawyer.

Write to your caseworker to ask for an update on your case

Get ALL information in your first language

You do not need to know the law to apply for bail

You do not need to speak English - you can get an interpreter

If you have a friend in the UK, ask if they can act as a "surety" - a person who is responsible for you. **YOU DO NOT NEED A SURETY TO GET BAIL.**
